The P&D Department of AJK has received financing from the World Bank towards the cost of the DCRIP, and intends to apply part of the proceeds for consulting services for Project Management and Implement Consultants (PMIC).

The Project Implementation Unit (PIU), DCRIP, P&D Department of AJK now invites eligible consulting firms (“Consultants”) to indicate their interest in providing the Services which comprise designing, planning and construction resident supervision of works for restoration of flood protection infrastructure.

Interested Consultants should provide information demonstrating that they have the required track record, relevant experience and suitable capacity to perform the Services. The short listing criteria are:

Criteria	Marks
General Experience (the consultant shall be a tax registered national management consultancy firm (for National firms only) or an international management consultancy firm incorporated for at least five (05) years for offering similar services.)	30
Specific Experience (The consultant should have completed at least five (05) similar projects of the same scale and/or complexity and in comparable organizations. Experience of working with Government of AJK would be preferred.)	40
Management Capacity (Volume of consultant’s services in terms of total number of staff months, as their specific input should be sufficient to indicate that the firm would be able to handle the requirements of this assignment.)	30
Total	100

Firms scoring at least 70 marks will be short listed for the assignment

The attention of interested Consultants is drawn to paragraph 1.9 of the World Bank’s Guidelines: Selection and Employment of Consultants [under IBRD Loans and IDA Credits & Grants] by World Bank Borrowers, January 2011 (revised July 2014).

Consultants may associate with other firms in the form of a joint venture or a sub consultancy to enhance their qualifications.

The Consultant will be selected in accordance with the Quality and Cost Based Selection (QCBS).
