Relevant Experience: The consultant should have completed at least Four (04) similar project of the same scale and/or complexity and in comparable organizations. Experience of working with Government of AJK. Specific experience includes General hydraulic studies, watershed management and other flood mitigation structure, and Related Project). The firm should have and demonstrate necessary experience and capacity of preparing environmental and social safeguards strategy & plans as per the requirements and guidelines of the World Bank and AJK Environment Protection Agency (EPA). The firm should have a team having expertise of more than eight years in the following areas: Civil, Geotechnical Engineering, Hydrology/ Geo-hydrology, Structural design, Watershed management, Bio-engineering, Surveying, Quantity surveying, Technical drawing, Environmental Impact Assessment, GIS and remote sensing. The team leader should have expertise of Geo-technical and bio-engineering who will be responsible for management and coordination of all project activities.	40
