1. The P&D Department of Govt. of AJK has received financing from the World Bank toward the cost of the “Disaster & Climate Resilience Improvement Project (DCRIP) IDA Cr. No. 5686-PK, and intends to apply part of the proceeds toward payments under the contracts for “Procurement of Works for Rehabilitation of Damaged Flood Protection Structures of Irrigation Sector”.
2. The Irrigation Department of GoAJK in collaboration with the Project Implementation Unit (PIU) DCRIP now invites sealed bids from eligible bidders for the following package;

3. The completion period of **Package-03** is twelve **(12) months**.
4. The Completion period of **Package-04** is nine **(09) months**.
5. Bidders may bid for one or both contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.
6. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank’s Procurement *Guideline: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011 revised July 2014*, and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank’s policy on conflict of interest.
7. Interested eligible bidders may obtain further information from PIU-DCRIP and can inspect the bidding documents during office hours **0900 Hrs to 1630 Hrs** at the address given below.
8. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application on the company letter head along with the company authorization letter of representative, to the address below and upon payment of a nonrefundable fee of PKR 6,000/- for each package. The method of payment will be “Pay Order” in favor of Project Director PIU-DCRIP or cash deposit. The documents are to be collected by hand.
