1. The P&D Department of Govt. of AJK has received financing from the World Bank toward the cost of the “Disaster & Climate Resilience Improvement Project (DCRIP) IDA Cr. No. 5686-PK, and intends to apply part of the proceeds toward payments under the contracts for “Procurement of Works for Rehabilitation of Damaged Flood Protection Structures of Irrigation Sector”.
2. The Irrigation Department of GoAJK in collaboration with the Project Implementation Unit (PIU) DCRIP now invites sealed bids from eligible bidders for the following package;

3. The Completion period is Eight **(08) months.**
4. Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank’s Procurement *Guideline: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011 revised July 2014*, and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank’s policy on conflict of interest.
5. Interested eligible bidders may obtain further information from PIU-DCRIP and can inspect the bidding documents during office hours **0900 Hrs to 1630 Hrs** at the address given below.
6. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application on the company letter head along with the company authorization letter of representative, to the address below and upon payment of a nonrefundable fee of PKR 6,000/-. The method of payment will be “Pay Order” in favor of Project Director PIU-DCRIP or cash deposit. The documents are to be collected by hand.
7. A Pre-bid Meeting will be held on **10th January, 2019 at 1130 Hours** on the address given below for the purpose of clarifying issues and answering questions on the Bidding Documents. Potential Bidders may choose to attend.
8. Bids must be delivered to the address below on or before **29th January, 2019 by 1130 Hours**. Electronic bidding will not be permitted. Late bids shall not be considered. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who chooses to attend at the address below **on same date at 1200 Hrs.**
9. All bids must be accompanied by a Bid Security as mentioned in **Para 2** above.
