A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application on the firm official covering Letter Head to the address below and upon payment of a nonrefundable fee of PKR:6000/=. The method of payment shall be Cash Deposit/Bank Pay Order. Upon the receipt of payment, the document shall be handed over to authorized representative of the firm or may be sent via courier on specified address in written request/application by the interested vendors.

6. The bidding document contains detailed specifications, instructions and conditions for those who wish to participate for the bidding process. Purchase of bidding document is mandatory to get a bidder qualify to participate in the bidding process.

7. Bids complete in all respect should be delivered to the address below on or before 05th March, 2019 at 1130 Hours. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who wishes to attend the bidding process at the address below on the same day at 1200 Hours.

8. All bids must be accompanied by a Bid Security @2 % of total bid amount in PKR in form of Pay Order/CDR/SDR.

General Terms & Conditions: -

1. The bidders shall quote their rates including all enforced taxes and duties in AJK for the supply of specified number of Ambulances on FOR Muzaffarabad basis.
2. Quantity can be increased or decreased by the competent authority.
3. Pre delivery inspection will be carried out by a designated Inspection Committee before shipment to the department. Upon arrival in the department, post-delivery inspection shall also be carried out.
4. Payment shall made after submission of pre-delivery and post-delivery inspection reports by the Inspection Committee.
5. Firms shall furnish copies of their active General Sales Tax and National Tax Registration Documents with the bids.
6. The Competent Authority reserves the right to accept or reject all or any quotations without assigning any reason.
7. Incomplete, Conditional, telephonic or offers through Fax or Email shall not be entertained.
8. Complete specifications, technical data and brochures of the quoted ambulances shall be provided with the proposals/quotation.
