The P&D Department of AJK has received financing from the World Bank towards the cost of the “Disaster & Climate Resilience Improvement Project (DCRIP) IDA Cr.No. 5686-PK, and intends to apply part of the proceeds toward payments under the contracts for “*Restoration of Flood Protection Structures of Package-2 (PP&H) Restoration of Flood Protection Structures along with Poonch River at Dakhari Park Kotli City & Restoration of damaged Water Supply Schemes at Kotli & Nakyal , District Kotli.*”
2. The Physical Planning & Housing (PP&H) GoAJK in collaboration with the Project Implementation Unit (PIU) DCRIP now invites sealed bids from eligible bidders for the following Package;

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank’s *Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011 revised July 2014* (“Procurement Guidelines”), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs **1.6 and 1.7** setting forth the World Bank’s policy on conflict of interest.
4. Interested eligible bidders may obtain further information from PIU-DCRIP and can inspect the bidding documents during office hours **0800 Hrs to 1600 Hrs** at the address given below.

A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application on the company letter head along with the company authorization letter of representative, to the address below and upon payment of a nonrefundable fee of PKR 6,000/-. The method of payment will be “Pay Order” in favor of Project Director PIU-DCRIP or cash deposit. The documents are to be collected by hand.
6. A Pre-bid Meeting will be held on **02<sup>nd</sup> May, 2019 at 1130 Hours** on the address given below for the purpose of clarifying issues and answering questions on the Bidding Documents. Representatives of potential Bidders may choose to attend.
7. Bids must be delivered to the address below on or before **14<sup>th</sup> May, 2019 at 1100 Hours**. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend at the address below **on same date at 1130 Hrs.**
8. All bids must be accompanied by a Bid Security as mentioned in **Para 2** above.
