The method of payment will be through Cash Deposit or Bank Pay Order in favor of Project Director, DCRIP. The documents are to be collected by hand or by Post/Courier Service. DCRIP shall not be responsible for any delay, if occurs, in delivery of BDs to the Bidder(s) by Post/Courier. Hence, Bidders are requested for sending the written request with Fee well in advance keeping in view of the bid preparation at their end and the specified delivery date and time given under paragraph 2 above.
- 7. Pre-Bid Meeting will be held on 26th July, 2021 at 1130 Hours in PIU-DCRIP AJK Office.
